From the 3:rd of January 2018 the protection for you as an investor was further strengthened through the implementation of two new regulatory frameworks, MiFID 2 and MiFIR. The purpose of these regulatory frameworks is to increase the transparency in the financial markets and to give you, as a client, an increased level of protection.

One part of this protection means that Mangold is required to ensure that the product you are about to purchase is appropriate for you and that you fall within the target market of the product.
